

## PUPPY PURCHASE AGREEMENT

This Puppy Purchase Agreement (“**Agreement**”), dated, \_\_\_\_\_ is between Brittanie Lanette Young (“**Seller**”) and \_\_\_\_\_ (“**Buyer**”) for the purchase and sale of the an AKC Standard Poodle Puppy (“**Puppy**”).

Accordingly, the Seller and Buyer agree as follow:

### Article 1—Definitions

### Article 2—Purchase and Sale

2.1 **Purchase and Sale.** Seller shall sell Puppy to Buyer in exchange for a total of \$ \_\_\_\_\_.

### Article 3—Seller Representations

3.1 **Good Health.** Seller represents Puppy is vaccinated early and receives two rounds of a typical six-way vaccination before seven (7) weeks old. This greatly deceases the likelihood of contracting a life-threatening disease.

3.2 **Deworming.** Seller represents Puppy is dewormed at two (2), four (4), six (6), and eight (8) weeks.

3.3 **Description of Puppy.** Seller does not guarantee size, weight, or type of coat Puppy may have at a later time.

3.4 **Vaccinations.** Seller represents Puppy has received all required and up-to-date vaccinations.

3.5 **Health Testing.** Seller represents both Sire and Dam have been health tested and are clear of the 172 testable genetic conditions.

3.6 **Registration.** Seller represents both Sire and Dam are registered AKC Standard Poodles.

### Article 4—Seller’s Covenants

4.1 **Delivery.** Seller shall relinquish rights of ownership of the Puppy at the time of pick-up.

### Article 5—Buyer’s Covenants

5.1 **Notification of Genetic or Hereditary Issues.** Buyer shall notify Seller of any life-threatening health defects found by a vet within 24 hours after the end of vet visit and include all information and documentation Buyer has received from Vet, subject to the attached health guarantee.

**5.2 Notification of Rehoming.** Buyer shall notify Seller if for any reason Buyer desires to rehome Puppy. Seller is not against Puppies being placed in a guardian home but would like to be informed. Seller reserves the right of first refusal to take Puppy.

#### **Article 6—Declarations**

**6.2 Further Vet Expenses.** Seller is not responsible for payment of vet visits incurred after this Agreement.
